Subject: Revised Sanction of Project under the National Afforestation Programme Scheme for implementation by State Forest Development Agency (SFDA) Gujarat– Approval of work-programme and payment sanction during 2012-13 for General Category – 2nd installment - regarding.

Sir,

I am directed to convey the sanction of the President of India to the release of Rs.300.00 lakhs (Rupees three crores only) as 2nd installment towards Grants-in-Aid to SFDA Gujarat project under the National Afforestation Programme Scheme for the financial year 2012-13 Plan Non-Recurring (General Category). The project shall be implemented by the SFDA Gujarat for carrying out 1740 ha for Advance work, 10430 ha creation and maintenance of plantation for 1st year, 2nd year and 3rd year in 465 ha., 7029 ha. and 16346 ha. at a total cost of Rs.2229.40 lakhs (Rupees twenty two crore twenty nine lakhs forty thousand only) at the wage-rate of Rs.183.80/- for the year 2012-13. Consolidated and FDA-wise detailed calculation indicating item of works, physical & financial is given in Annexure-I & Annexure-II. This is in continuation of this Ministry's sanction letter of even No. dated 29/6/2012.

2. All relevant documents/certificates would be submitted by the implementing agency after completion of project of the year 2012-13 and while requesting for next installment during 2013-14. The unspent balance of Rs.549.60 lakhs has been adjusted in the work programme of 2012-13. Copy of Utilisation Certificate has been enclosed.

3. The grants-in-aid will be regulated in accordance with the provisions contained in the Guidelines of Ministry of Environment & Forests, Government of India, New Delhi. The Grants-in-Aid is also subject to the Chapter 9 of the General Financial Rules, 2005, as amended from time to time, read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions:-

- (i) All relevant information and documents/ certificates as required under NAP Guidelines have been received.
- (ii) The pattern of assistance of rules governing such grants-in aid have received the approval of the Ministry of Finance, as required under Govt. of the Decision No.(1) under DFPR – Rules 20.
- (iii) No staff is to be provided specifically for the scheme.
- (iv) Assets acquired wholly or substantially out of Government Grants shall not be disposed off without obtaining the prior approval of the sanctioning authority of Grants-in Aid.
- (v) The Accounts of Gujarat SFDA shall be audited by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in section 14 of the C&AG(DPC)1971 as amended from time to time.
- (vi) The Accounts of Gujarat SFDA shall be open for inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of C&AG (DPC) Act 1971
